BVU Membership is available to 501(c)(3) organizations, municipal, county, state, and/or federal agencies, and certain 501(c)(6) organizations (e.g. Chambers of Commerce) that are compliant with federal policies and regulations, operate out of a non-residential office, and employ the equivalent of one full-time paid staff member.
